IT LOOPS APPROXIMATELY EVERY 10 MINUTES, TOTALLING THOUSANDS OF AIRINGS. THIS CHANNEL IS ON THE MAJOR CABLE SYSTEMS IN CONNECTICUT. OUR SECOND DIGITAL CHANNEL IS A FAIRFIELD COUNTY, CT SECTIONAL. THIS CHANNEL BROADCASTS THE SAME PROGRAMMING AS WFSB, WITH DIFFERENT COMMERCIALS AND PROMOS. THE DTV CRAWL AIRS IN THE NEWSTICKER EVERY MONRING FROM 5AM-9AM, LOOPING EVERY 10 MINUTES. AND WE RUN THE REQUIRED 16 DTV PSA'S A WEEK.
